



CERTIFICATION FOR DETERMINATION OF PROBABLE CAUSE

That Russ Weklych is a Detective with the Seattle Police Department and has reviewed the investigation conducted in Seattle Police Department Case Number 06-313988;

There is probable cause to believe that Naveed Afzal Haq 9-23-1975 committed the crime(s) of Murder and Attempted Murder.

This belief is predicated on the following facts and circumstances:

On 7-28-2006 at 1603 hours a lone gunman, later identified as Naveed Afzal Haq 9-23-1975, entered the Jewish Federation of Greater Seattle located at 2031 Third Ave, City of Seattle, County of King and State of Washington. When Haq entered the building he was armed with at least two handguns and extra ammunition.

Haq forced his way into the premises by forcing a 13-year-old girl to let him in by putting a gun into her back. He then entered the premises and made several statements indicating anger at Jews. Haq opened fired from at least one handgun. All of the victims were women including one pregnant woman who was shot in the arm. This victim was able to make a phone call to 911 while the shooting was occurring. She told the 911 operators that the gunman Haq had shot people and was holding her hostage. As the 911 operators asked where the gunman was the wounded victim said "right here" and the gunman took the phone. The gunman got on the phone and said, "this is a hostage situation, I have a hostage." The 911 operators asked the gumman's name he replied "Naveed Haq." Haq said, "This is a hostage situation and I want these Jews to get out." He stated he was "at 2131, the Jewish Federation, on 3 Ave." In response to various questions Hag stated, "I'm upstairs. I'm not upset at people I'm upset at your foreign policy. These are Jews and I'm tired of getting pushed around and our people getting pushed around by the situation in the Middle East." He repeats his name as Naveed Haq and gives his social security number as 288-72-2466. He states, "I just want us to get out of Iraq, I'm an American too but I want our people out of Iraq." Hag states that he has one pregnant female at gunpoint and "I shot her once, I shot her in the arm."

Haq states he wants Police to call the media and tells the 911 operators "I have this gun pointed at her head." When the 911 operators say she needs an ambulance he states, "I don't care." Haq tell the 911 operators he is "acting alone", that he has not been drinking today.

Hag suddenly states, "Ill give myself up." In response to questions he states he is "wearing a green shirt, blue pants, I'm in jeans." He states, "I'll put my gun down." He states, "She says my gun is down." The 911 operators ask whom and Haq states "the woman I just shot."

Two handguns were recovered at the scene of the shooting: a .40 caliber semi automatic and a .45 caliber semi automatic. Haq shot 5 people, fatally wounding one. The 4 surviving victims suffered gunshot wounds in the abdomen, groin, and extremities. At the time of this affidavit, 3 victims are in emergency surgery at Harborview Medical Center and are in critical condition.
