also stated that the S/ [redacted] told her that he would take her dog away. While talking to [redacted] on the phone, I/O was dispatched to a call. I/O informed [redacted] that I would call her back. I/O made two attempts to speak with [redacted] but was unsuccessful.

On 03-16-07, at 1320 hours, I/O was informed that [redacted] was at the front counter of UWPD. [redacted] stated that she came down to give I/O more information about her case. [redacted] also stated that [redacted] only calls and made the above threats when he is drunk. [redacted] related that she knew [redacted] for a total of six years, and that she broke up with him about two years ago. [redacted] also related that [redacted] keeps changing phones, and would always call from those pay-as-you-go phones. [redacted] also gave I/O a picture of [redacted] and copies of a protective order that needs to be served on him, which is documented under Superior Court of Washington, King County, No. [redacted] 4SEA. See attached picture of [redacted] which is attached to case file. [redacted] related that [redacted] has no local address, and does not know how to get a hold of him. [redacted] also related that she is not sure if he drives a vehicle, or if he has any weapons. The first incident occurred on 03-07-07, at 1820 hours, and the second incident occurred on 03-14-07, at 2300 hours. On both incidents, [redacted] received the harassing phone calls while working at [redacted] mall. [redacted] does want to prosecute on the above charges.

[redacted] stated that [redacted] does not know where she lives, nor what type of vehicle she drives.
