That on or about the 26th day of August, 2005, the said defendant, MICHAEL ANTHONY MULLEN, then and there being in said county and state, with premeditated intent to cause the death of another, did cause the death of Victor Vasquez, a human being, where there was more than one victim and the murders were part of a common scheme or plan, or the result of a single act of the defendant, where the defendant was armed with a firearm in violation of RCW 9.94A.533, all in violation of RCW 9A.32.030(1)(a) and RCW 10.95.020(10), a class A felony.

AGGRAVATED MURDER IN THE FIRST DEGREE WHILE ARMED WITH A FIREARM, COUNT II

That on or about the 26th day of August, 2005, the said defendant, MICHAEL ANTHONY MULLEN, then and there being in said county and state, did, with premeditated intent to cause the death of another, did cause the death of Hank Eisses, a human being, where there was more than one victim and the murders were part of a common scheme or plan, or the result of a single act of the defendant, where the defendant was armed with a firearm in violation of RCW 9.94A.533, all in violation of RCW 9A.32.030(1)(a) and RCW 10.95.020(10), a class A felony.
